

## Cookie policy

When using the website, the protection of your privacy is of key importance for BorsodChem Zrt. (hereinafter referred to as “**BorsodChem**” or “**Controller**”), therefore you can find detailed information below on the collection of personal and non-personal data.

Be advised that you can use the website of BorsodChem without providing any personal data. The following information applies to data processing performed in terms of the cookies (hereinafter referred to as “**cookie**”) used on BorsodChem Zrt.’s website and serves to inform the data subjects (thus e.g. you as a private entity visiting our website). The objective of this document is to provide exact information in full compliance with the laws as to why and how we process the personal data of those private entities who visit the Data Controller’s website. BorsodChem does not collect or process any such data on its website by which you could be clearly identified.

We inform you that BorsodChem shall exclusively be responsible for the website content.

### 2. Laws considered in the course of preparing the current informing document:

- Decree 2016/679 of the European Parliament and Council (“GDPR”);
- Hungarian Act CXII of 2011 on the information right of self-determination and freedom of information;
- Hungarian Act C of 2003 on the electronic telecommunication.

### 3. What are cookies?

A cookie is a small text file, which is stored by the website you visited either on your computer or any other device used for browsing the Internet. Your device stores the cookie for a definite period of time, which enables the visited website to “remember” specific data and settings (e.g. language, font size and other display settings) for a specific duration.

### 4. Legal ground of data processing

With the exception of cookies essentially required for operation of the website (which do not collect information qualifying as personal data) the application of cookies is based on the your expressed voluntary consent provided in the possession of proper information and it constitutes the legal ground of related data processing.

Be hereby informed that if you give your consent to use of the said cookies, BorsodChem will not collect or process any personal data related to you in a way on which basis you as a user could be identified personally.

## **5. Provision and withdrawal of consent**

As a data subject, provide your voluntary consent by means of your active conduct by clicking on the “ACCEPT” button when the brief info window on the use of cookie pops up. When you visit the website for the first time a so called “cookie window” appears, on which you can see the cookies used on our website grouped (Article 7 of the current Cookie Policy).

You can give your voluntary consent separately via the pop-up “cookie window” related to the use of cookies for statistical and marketing purposes by moving the switches next to the “ON” side.

You can modify the settings – and also withdrawal of consent within this scope – anytime on the website under the menu item of “Cookie settings” by moving the switches to the “OFF” side. In addition, you can delete all cookies used by the website at the same time by clicking on the "Delete cookies" menu item. Please note that when using the "Delete cookies" menu item, the "Essential Basics" cookies will be re-installed on the website / device after deletion, as they are absolutely necessary for the operation of the website.

## **6. Retention time**

You can receive information on the expiry date of cookies used on BorsodChem website from the chart in Article 8 of this Cookie Policy.

We hereby draw your attention that the cookies can be deleted earlier if you delete them from your computer or other device. The so called “Work session cookies” are exception, which are processed until closing the visitor work session, i.e. until leaving the site

## **7. Types of applied cookies**

### ***A. “Essential basics”:***

These cookies are essential for the operation of BorsodChem website. They are definitely necessary for the technical operation of our website, they help to make it easy to use, for instance for the sake of navigation on the site, storage of user demands or settings and as a result it is not possible to switch them off, yet at the same time these cookies do not collect any information qualifying as personal data.

### ***B. “Statistics”:***

Such cookies collect data through an anonymous identifier, thus they do not store personal data. These cookies help us analyse the website performance and develop our website. Moreover, they also provide information for us on the number of users, the number of downloaded pages, the device from which the visit was paid (type of mobile, desktop computer, tablet, operating system) and on the frequency of visit without the clear identification of users. Furthermore, the aim of cookies is to become familiar with the use of website by the user (e.g. visited sites, navigation, duration of work session) so that we could further develop the website in line with our visitors’ demands as well as ensure a high standard and user-friendly experience.

Since BorsodChem uses the data collected by cookies for statistical purposes in various analyses, you can read about it in more details in Article 9 of this Cookie Policy.

**C. “Marketing”:**

The aim of these cookies ensured by external service providers is that advertisements that increasingly interest you or giving cause for interest should appear on the website thereby. These cookies cannot identify you either personally and they may collect information such as e.g. what page the visitor visited, which part of the website the user clicked on, how many pages he/she visited so that you could become familiar with the contents of your interest.

*We call your attention that BorsodChem does not use the data collected in the course of using cookies for marketing purposes.*

**8. Detailed listing of applied cookies**

We inform you that by using this website other web cookies from a 3rd party may also get to your device, which facilitates the sharing of contents on community sites, preparation of visiting statistics or support of our marketing activity.

In such cases, the data protection regulations defined by these third parties shall be prevailing for data processing and in respect of such data processing BorsodChem shall not assume any responsibility and BorsodChem has no impact on their operation. You can exercise a higher-level control over the web cookies by way of the settings performed in your own browser (banning, withdrawal). All modern browsers permit the change of cookie settings. Most browsers as default automatically accept the cookies, but it is possible to ban cookies from the third party, restrict the retention time, ban in general and define exceptions.

## 9. Google Analytics

BorsodChem utilises services of the Google Analytics system in terms of its website. Google Analytics is the analysing tool of Google, which helps BorsodChem receive a more exact picture about the activity of visitors to its website (also including your activities) and performance of the website without individually identifying the visitors.

The primary goal of data collected by Google Analytics cookie and their use is that BorsodChem could properly operate its website, for which it is especially required to monitor the website visiting data (e.g. number of visits, tools usage). In addition to the above, BorsodChem may use this information to analyse the utilisation tendencies, improve and develop the functions of its website as well as analyse the website performance.

Since Google Analytics comes from an external 3rd party service provider (Google Inc.), Google may also use the data collected by it (including data originating from your activities realised on the website) for instance that more relevant advertisement could appear in the Google-services (such as Google Search) all over the Internet and they could measure the interactions related to advertisements displayed by Google. Furthermore, Google is authorised to forward these data to third parties utilised for data processing thereby. ## 10. Data subject rights

You may delete the cookies installed on the devices anytime from your own computer while using the website and you may ban their application in your browser anytime. Be advised that the deletion of cookies may result in the improper operation of certain parts of the website or the short text of cookie information appears again when visiting the site. You may receive more detailed information on the ban of cookies in the browsers and its settings on the browsers website.

In case of cookies processed on the grounds of your consent, you may withdraw your consent given to any cookie anytime, but we call your attention that withdrawal of the consent does not concern the lawfulness of data processing based on consent before withdrawal.

## **11. Right of objection**

If you think that BorsodChem as Controller processed your personal data unlawfully, BorsodChem recommends that the data subject should definitely contact either BorsodChem on any of the contact details as per the above Article 1 in order to clear and settle the case amicably as soon as possible.

If it failed to be successful or the data subject refused to avail of this option, the data subject – without any injury to other public administration or court remedies – has the right to file a complaint at the competent data protection supervisory authority of the Member State in which he or she has his or her habitual residence or where the alleged breach took place. In Hungary a complaint can be filed at the National Authority for Data Protection and Freedom of Information (NAIH). In case of violation of law, the data subject may also apply to court (judgement of the lawsuit falls within the competence of the court of justice) and he/she may decide to initiate the proceedings before the competent court according to his/her address or place of living
